Dear Mr. Gloria:

Under the Nevada Open Records Act § 239 et seq., please identify the persons appointed to the accuracy certification board relative to the 2022 election, including their political party, in compliance with NRS 293B.140. Please provide all documents pertaining to the criteria or policies used in this determination to select these people, and whether the same people will serve on the board in the general election.

Of concern, please see the attached screenshots where campaign manager Lisa Mayo DeRiso stated that she was selected to sit on the 'Clark County Election Certification Board'. As Mayo DeRiso is directly employed by several candidates by both parties, this is a clear conflict of interest. If this board is different than the specified board below, please provide clarification:

**NRS 293B.140 Appointment of accuracy certification board.** Before conducting the test required pursuant to the provisions of NRS 293B.150, the county or city clerk shall appoint three persons, not more than two of whom are of the same political party, to serve as an accuracy certification board. Not more than two of the persons appointed to the board may be employees of the county or city.

This would include any form of written correspondence (emails, texts, encrypted messages, etc) and any phone records between any member of your elections department, yourself, and these on this 'Certification Board'. We would also request a summary of any phone conversations between yourself, members of your department, and any individuals that have been appointed to the 'Certification Board'.

If there are any fees for searching or copying these records, please inform me if the cost will exceed \$100.

However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of election integrity and processes for future elections. This information is not being sought for commercial purposes.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
